NOW THEREFORE, in consideration of the above stated premises, Indemnitor agrees that it will defend and indemnify Indemnatee and the Prosser Farmers Market and their officers, employees, and agents against, and save harmless from all claims, suits, damages, costs, losses and fees, including attorney fees, resulting from, arising out of, or connected with the Indemnitor's sale of fruit, produce, or other commodity at the farmers market located at the city park, 7<sup>th</sup> Street and Sommers Avenue.
